The Sheriff's Office still remains very busy investigating crimes that were reported in the previous administration as well as new reports that come in. We will remain diligent in the investigation of crimes and the attempt to solve each one of these. There still remains issues that are being addressed to improve the operations of the Sheriff's Office.

1. Begin the process of hiring new Court Security Officers(CSO) to work in the court room. This will clear the Sheriff and Chief Deputy/Detective to complete the investigative work that needs to be completed throughout the County. The goal is to hire two part time CSOs to handle the court security.
2. Reviewed grants that may be available to the agency for overtime and equipment. Completed a Homeland Security Law Enforcement Protection Program (LEPP) Grant for equipment for officers in the Sheriff's Office.
3. Continued to look at ways of improving service that the Sheriff's Office provides to the citizens of Bracken County. The Sheriff's Office remains dedicated to providing the best service it can to the citizens and making Bracken County a safe place to live, work and play.
