JUNE MONTHLY REPORT

The Sheriff's Office activity during the month includes but is not limited to:

1. The Sheriff's Office received a Prescription Pill Drug Box from the Kentucky Crime Prevention Coalition. The box is available during court house hours for citizens to drop off unused prescription drugs that may be lying around the house. This continues our fight against drugs to make this a safer county.
2. Bracken County Sheriff's Office participated in the Click It or Ticket National Campaign to improve seat belt usage. The department worked overtime hours during this campaign that will be funded by a \$1,000.00 Highway Safety Grant. This program ran from May 23-June 5, 2011.
3. Bracken County Sheriff's Office held its second Town Hall Meeting at the Fairview Christian Church on June 14, 2011. Approximately 35-40 citizens showed up for the event. Crime prevention information was available and an informational update was given on the activities of the Sheriff's Office. There were no concerns or issues raised at this meeting.
