

# Bracken County Sheriff's Office Administration

## OCTOBER MONTHLY REPORT

The Sheriff's Office activity during the month includes but is not limited to:

1. Sheriff Niemeier participated or attended the following events/activities during the month of October: Jim's Auto Customer Appreciation Day; Charlie Walters Chili Cookoff/Social; Northern KY Police Chief Association Meeting; the 911 Board Meeting; Fairview Church Trunk and Treat; and Sheriff Niemeier and Deputy Riley patrolled the Cities of Augusta and Brooksville during Halloween Trick or Treat hours.
2. The Bracken County Sheriff's Office with assistance of the Newport Police Department and Campbell County Detention Center worked with the Bracken County High School in conducting a Drug Sweep of the school premises utilizing drug K-9 dogs. No drugs were found during this drug sweep to include the parking lot.
3. Bracken County Sheriff held the 4<sup>th</sup> Town Hall Meeting at the Germantown Community Center/Fire Department. There were approximately 20 citizens in attendance who came out to hear the Sheriff give an overview of the activities of the Sheriff's Office, stats and to receive crime prevention information. Two issues were voiced at the meeting: speeding on KY 875 and kids hanging out on lot of Funeral Home.
4. Bracken County Sheriff Office participated in the Drug Enforcement Administration's (DEA) Drug Take-Back Program for citizens to safely dispose of their outdated or no longer used prescriptions. Citizens were able to drop of drugs at the Sheriff's Office. During this event the Sheriff's Office collected 18 pounds and 6 ounces of drugs to be destroyed by the DEA.
