

Notice to Delinquent Taxpayers of Bracken County, KY

The following delinquent 2009 tax bills upon which there is real estate will be offered for sale in the Bracken County Clerk's office at 9 a.m., Monday August 16, 2010.

To these bills (tax claims) a clerk's fee and cost for advertising will be added on the day of the sale.

The purchaser of any tax claim will be issued a certificate of delinquency, which becomes a lien upon the real estate described on the face of the tax bill. This certificate of delinquency is subject to 12 percent interest per annum from the date of issuance.
